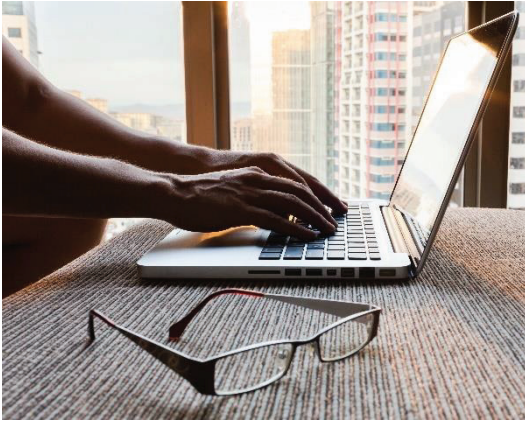

The Archive Bridge allows CAS client and discovery applications to query Enterprise Vault directly and retrieve content via all of the primary CAS end-user interfaces for search and eDiscovery. Legacy Enterprise Vault installations remain in place in a static or active mode and are utilized synchronously with CAS 1.0, a 'migration free' move to a new solution!

The CAS Archive Bridge provides open-ended flexibility so that clients have the option to retain search and access of Enterprise Vault data capabilities, in parallel with a new CAS 1.0 deployment or as part of a phased migration away from Enterprise Vault to CAS 1.0. The CAS Archive Bridge removes all of the traditional constraints from the archive migration lifecycle to empower our clients, mitigate risk, and reduce expenditure.

**Direct Archive Access** – The Archive Bridge connects directly into your existing Enterprise Vault archive, accessing your original data where it resides, complete with proper access control and results accuracy.

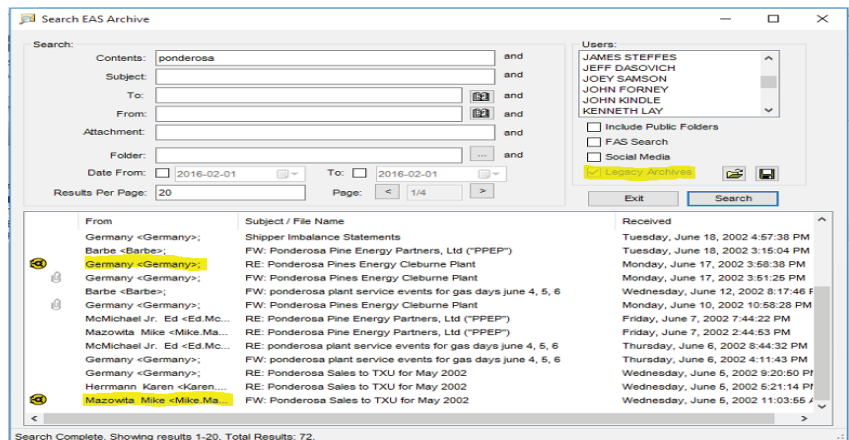
